REV. ANSELM ANTHONY?

Anselm Anthony, b. June 6, 1779, d. June 6, 1868, son of Joseph Anthony, Jr., and Elizabeth Clark, md. (1) Dec. 16, 1804, Sarah Menzies, b. Feb. 6, 1778, d. Oct. 11, 1832, md. (2) Jan. 15, 1837, Katherine Blakey, b. Aug. 18, 1793, d. Oct. 4, 1843, (Ga. Hist. Collection.)

History of Georgia Baptists with Biographical Compendium, published 1881. Biographical sketches section, p. 8 gives his picture and this article:

Anselm Anthony was born on the 9th of June 1778, in Campbell County, Va. He was the son of Joseph Anthony and his wife Ann Clark, daughter of Colonel Clark an officer in the Revolutionary War. Shortly after that war Joseph Anthony moved to Georgia and settled in Wilkes County. Here Anselm obtained educational advantages only as were afforded by country schools; but being fond of books, he devoted all his leisure hours to reading, and amassed a great fund of information. Even at that age he was calm and dignified in his deportment and gentle and courteous toward his associates. He began to preach about 1810 or 1812 and was licensed by Fishing Creek Church, Wilkes Co., Ga., in 1814 and for a while had charge of that church. Then he became pastor of the Baptist Church at Madison, Ga., for several years in that place, serving also, other churches in Morgan Co. In 1824 he moved to Cwinnett Co. where he served various churches. He was married in 1806 to Sarah Menzies of N. C. who died in 1830. Eight children, 3 boys and 5 girls were the result of this union. After remaining a widower five years, he was

United in Matrimony to Miss Catherine Blakey, of Wilkes Co., Ga. About 6 yrs. after his second marriage, a stroke of paralysis, which affected one entire side of his frame, and from which he never fully recovered, put am end to his ministrial work.

In 1843, his second wife died, and he lived alone until 1858, when he was induced to break up house keeping and reside with his son in Meriwether Co. While on a visit to his daughter in Polk Co. in Jan. 1859 he became helpless and remained so until Jan. 1868 when he died in the 89 year of his age. When informed that his departure was near at hand, he said, "I know it, but I feel that the Lord is with me and that he will never leave me." Calm and peaceful was his departure from earth. Never did evening set more softly and gently, than this way-worn pilgrim fell asleep in Jesus. Without a struggle he closed his eyes in death-

"Like one who draws the drapery of his couch about him, and lies down to pleasant dreams."

His body was taken to Gwinnett Co. and rests in the grave at Bethabara

Church, beside the remains of his wives and daughters.

Mr. Anthony was a hard student, and with him the Bible was the book of books. For it's study he set apart a portion of each day and permitted neither business nor friends to cause neglect of this duty. As a preacher he was plain and pointed, ever reproving sin regardless of praise or censure; and as long as he could converse he admonished to holiness of life, and to earnestness in performance of Christian duty. He would, sometines, tell how a couple of sisters encouraged him on the day of his baptism, saying, "I was sorely tempted by the devil, and almost ready to yield when they came to me and exhorted me to be faithful. They did much to strengthen me. Sisters," he would say, "go and do likewise, you may encourage and strengthen many who are weak, and ready to faint."

To the last he was deeply concerned for the interest of Zion; and even when memory failed to such an extent that he did not recognize the members of his family, he never forgot the name of Christ nor that of Christ Church. He would inquire of all he saw how the cause of the Savior was progressing and how Zion was prospering. As a man and as a minister, he was slow to form an opinion and give expression to his sentiments, in regard to either men or measures; but when his opinions were settled and his judgement formed, he remained firm and unyielding.

He was a large man and of muscular proportions weighing 240 lbs. with raven hair and large black eyes, but with a weak voice and soft-spoken, he commanded the respect and attention of his audiences. Without a doubt he did much good by wholesome advice he was in the habit of bestowing on the young, many of whom, even in old age, remember and often respected the judicious instructions received in youth from him. Upon more than one boy's mind was a lasting impression made by this saying of his: "When angry bottle up thy thunder and lightning lest thee kill some one!"

As a minister he was in the hands of God, an instrument for turning many from the evil of their ways, to the path of righteousness and peace, and no doubt, in the great day, many will call himm blessed. As a Baptist he was sound in faith and practice and strong in his doctrinal convictions and did much to establish wavering brethern.

EDWIN B. ANTHONY

Biographical Souvenir of The States of Ga. and Fla.:

Edwin B. Anthony, M. D. of Griffin, Spaulding Co., Ga., was born in Meriwether Co. in the same state, Dec. 22, 1852, and is a son of Dr. Joseph W. and Martha (Mender) Anthony. Dr. Joseph Anthony was a native of Elbert Co., Ga. and was born in 1805. His early medical education was obtained at the medical department of the University of Pennsylvania but he received his diploma on graduating from the Transylvania University at Lexington, Ky. in 1828. For forty years he practiced in and around Greenville, Ga., and was regarded as one of the ablest and most successful physicians of the state; and no man stood higher professionally, socially and religiously than he. For many years before his death, in 1875, at the age of seventy, he had been a deacon in the Baptist Church and liberal contributor to all church and charitable organizations. He was an able and frequent contributor to the Baptist and other religious journals, and articles were highly appreciated and admired. Dr. Edwin Anthony, the youngest of a family of six living children, received his education at Auburn College, in eastern Alabama. read medicine with his father, took a course of lectures at Atlanta Medical College, and graduated from the University of Louisville, Ky, 1879, taking a gold medal. He practiced in Greenville, Ca. until 1879, when he removed to Criffin, where he has since been engaged in active practice. He is a member of the State Medical Association, and at it's last meeting, in 1888, was elected it's vice-president. He is also a Royal Arch Mason, an Odd Fellow,

and a member of the Baptist Church.

In 1878 the Dr. married Miss Addie Wimbish, daughter of Dr. H. S. Wimbish, and is now the happy father of four children, viz: Scott, Render, Addie and Edwin, Jr., the oldest child Mary died in infancy.

Letter written by Dr. Edwin B. Anthony:

Griffin, Georgia 9-26-1908

Mrs. Vara Anthony Christian Athens, Ga.

Dear Cousin:

You must pardon my delay in answering your letter. I have been trying to get information from various sources in regard to the Anthony family which I thought would be of interest to you. I have been trying to find out positively whether or not our ancestors fought in the Revolutinary War.

Ex Covernor Allen D. (Daniel) Candler whose great grandmother was a daughter of our great grand grandfather, Joseph Anthony, was the wife of William Candler who was one of the heros of Kings Mountain and Blackstock Farm. I thought possibly that one or all six of Joseph's sons might have fought in the Revolutionary War. I talked (?) with Gov. Candler in regard to this matter, but he could not tell me whether any of the sons fought in the Revolutionary Army. On the other hand Gov. Candler says they were all Quakers, and it was against their creed to go to war.

A few years ago, Gov. Candler found a family tree of the Anthony family among the Archives of the state and gave my sister, Mrs. Stozier of Green-ville, Ga. a copy. The tree was in a dilapidated condition and my sister pasted it together with paste made of flour and sent it to me last January. Since receiving your letter, I wanted to refer to it. I went to my library drawer to get it and to my sorrow and astonishment I found the mice had nearly destroyed it. I can gather enough from it however to give you the following facts.

Mark Anthony, our great great great grandfather was the son of a wealthy merchant who lived in Genoa. He moved from Genoa to Holland and when Mark was about seventeen years of age, sent him along with a neighbor's son back to Italy to be educated. Mark and his companion, tired of school, ran away from home and embarked on a ship. They were taken prisoners by Algerine pirates and sold into slavery.

One day Mark and his companion were cutting wood in the forest under the direction of their master who was a most cruel master. They killed their master, made their way to the seashore and embarked on a British ship under cover of darkness. They prevailed upon the British captain who was just ready to sail to America to hide them in a hogshead as merchandise until they got well out to sea. The British captain landed them in New Kent, Va. about 1698, and sold them for three years to pay for their passage.

At three years expiration, Mark Anthony married Isabella Hart. He settled in Bedford Co., near the present site of Lynchburg, Va., and raised 10 children. The third, our great great grandfather, Joseph Anthony, was born 1713 and married Elizabeth Clarke in 1741. They had 15 children, eight daughtars and seven sons. One died in childhood; Penelope married a Johnson (James), they were the great grand parents of the Confederate General Joseph E. Johnson Rachel married a Ware (other places give James Lane). Jane married

a Carter (others show Winifred md. a Carter).

Micajah, our grandfather, married a Williams (Rebecca). They raised one daughter who married a Huff. Five sons: Mathew, Mark, Thomas, Joseph, my father, Micajah. All these married but I do not know whom and raised famies. My father Joseph W. married a Render, a descendant of Christopher Anthony, our great grandfather's son.

My mother and father had 10 children of whom I am the youngest. Four died in childhood and six, three daughters and three sons, lived to be grown. My eldest sister married Dr. Joseph Terrell and were the parents of Ex. Cov.

J. M. Terrell.

My sister Agnes married a Stozier. Lutie never married. Judson married a King. Joseph married a Hussey. I married a Wimbish and have three children living, two sons and a daughter. I have two children dead. My oldest died in infancy, my eldest son Scott was one of the most promising physicians in the state. He died last March in his 27th year.

Now you have the history of the Anthony family as near as I can give it. You can copy the foregoing for Miss Anne Lane and for cousin John's widow and send each one a copy with my compliments. I do not know Mrs. Slatter. Who is she? I would be glad to have a letter from her and cousin John's widow.

From our great great grandparents Joseph Anthony and Elizabeth Anthony have descended no less than 15 prominent families in Virginia.

Among the Cabells and Johnsons and 15 in Georgia among the Coopers, Candlers, Carters, Hamiltons, Brannhams, Stovals, Nisbutts, Terrells, Jordans, and Tates.

Six sons of our great grandfather all settled in Georgia. Three immediately after the Revolutionary War. Robert Tombs married Mary Anthony, the descendant of one of these boys. I do not know which. Gov. Stevens was a near relation to my father (he was president of Confederate States of America). I was certainly glad to get your letter and hope you will write again soon. If I ever visit Athens, I will be sure to call to see you. I am a perfect slave to my profession and to my patients and out of my busy life have but a few days I can call my own. Would be glad to see you or any of the relatives at anytime, my home is Griffin. Write to me soon.

Excerpts from a letter of Mrs. J. D. Anthony, Rt. 2, Dahlonega, Ga. 30533:

This E. R. Anthony was a physician and at one time was secretary-treasurer of the Medical Examiners of the State of Ga. Dr. T. B. Anthony's 1st wife Ann R. Carter, had a half brother, William Strong, who was very wealthy.

"Now if there be a lawful Cause to obstruct the same then the Above Obligation to be Void and of no effect. Otherwise to Remain in full force & Virture.

Among those taking this oath on Dec, 31, 1777, Were: James Anthony and Thos. Cooper.

Anthony) Thompson, Columbia, Mo., pub. 1933. State Historical Society of Mo., University Library Building, Hitt and Lowry, Columbia, Mo., has a copy. This booklet of about 18 pages is a copy of the Ana-Baptist Church record preserved in the family of it's 1st. pastor, Rev. Joseph Anthony, who may have been a 1st. cousin of James Anthony, who signs as clerk on pages 1-7. Page 1: Dec. 26, 1786, gives an account of the constitution of the church-Brother Lawrence reported Joseph Anthony and Jane Anthony and others were ripe for constitution. Pronounce them a church.

ALICTA NANCY (ANDERSON) WILLIS

Miss Eliza Bowen states in her book, The Story of Wilkes Co., Ca., that "I have seen several letters written in 1812 to a young girl 13 years old who was a pupil at the old Brick Academy in that year. She was Nancy Anderson and became in after years the wife of James D. Willis and the mother of Mrs. Lucy Simpson of 1889. She boarded in Washington at the house of Mr. Omborne fitone, the father of our Mrs. Samuel Barnet, then married to his first wife. Her father, Mr. Thomas Anderson, writes that he is coming to see the examination "next Wednesday" and hopes "you may be one among the best." Her aunt, Miss Mary Anderson writes a letter and says, "I was informed that you got the praise of the school." Her grandfather, Mr. James Anthony, who has several descendants around Washington now says, "Remember a virtuous young lady is like a piece of clean paper; if it gets blotted, it cannot be got out without injuring the paper." There is a letter written in September after Nancy Anderson left school, by one of her school mates, Miss Nancy Booker, who was, I presume, a great aunt of Mr. C. Booker. It was evidently written in the school room, for she complains of the boys shaking the desk. School was out, and I suppose the boys were preparing to go home. From her letter it seems Mr. Ezra Fiske was the teacher. The Writer says Mr. Friske is going away and adds, "I am sorry."

HENRY TATE ANTHONY

Henry Tate Anthony, b. Henry Co., Va., 1778, d. 1861, son of James Anthony, Sr., and Ann Tate, md. 1805, Mary Caroline Lovell, b. 1781, d. 1863. He was listed in the land lottery 1803.

Wilkes Co., Inferior Court minutes: Sharman Parks, orphan of William Parks, dec'd, bound to Henry T. Anthony, carpenter, said Sharman bound formerly to James Alexander. (Listed with other articles dated 1817.)

Henry Anthony was the first owner of the lot, 301 S. Alexander, Washington, Ga., in 1817, now the very historic home of Mrs. Raymond Rockford Johnson. The family of Jefferson Davis stayed in this house in 1865 at the end of the Civil War, waiting for Pres. Davis after the surrender.

Mary Caroline Lovell is probably the Polly Anthony mentioned in the will of William Lovell: Whole estate to wife for life or widowhood; To daughter, Polly Anthony, a slave; To children of daughter, Lucy Bird, a slave; To sons Wm., Lemuel and Benson, a slave each and land equally divided except where and including the graveyard, Aug. 27, 1818.

Henry Tate is not listed in the 1820 census of Georgia. One source states that he married in Tuscaloosa, Ala., and died there, having six children. Abridged Compendium of Am. Gen. lists these descendants:

James Anthony, Jr., b. Apr. 16, 1782, Henry Co., Va., d. Mar. 10, 1853, Forsyth, Ga., 5th child of James Anthony, Sr., and Ann Tate, md. (1) July 19, 1804, Elizabeth C. Blakey, b. Jan. 3, 1789, d. March 13, 1828, dau. of Winefred Anthony and Joseph Blakey; md. (2) Lucinda Menzies, (no court record found on this marriage). (Menzies is the name of a Scottish Clan.); md. (3) June 21, 1836, Mrs. Nancy Gordon, ceremony performed by Rev. Samuel Anthony, recorded Marriage Book A p. 108, Monroe Co., Ca. The dates of births, deaths and marriage of James, Jr., and Elizabeth C. were recorded in the Bible of Robert McCenis Anthony, in possession (1966) of Mrs. T. Ed. Green, 506 Rosamond St., Houston, Texas. Mrs. Eugene (Anthony) Harris, stated in a letter that her grand parents were first cousins, and mentions "my father's grandmother Carter."

Land Lottery, 1807: James Anthony, Jr., living in Wilkes Co., Ca., drew Lot no 82, Norman's Militia District No. 13, Baldwin Co. Only the western part of the present Baldwin Co. was in the lottery. Jones Co. was formed 1807, from Baldwin, Bibb, and Putman counties.

Morgan Co., Ga., record, Deed Book C p. 15: James Anthony of Jones Co., Thomas Blakey and Nancy Blakey of the one part to Wm. Swift - a lot no.94-5, dist. Jan. 10, 1811.

About 6 of his children's marriage records are recorded in Talbot Co., Ga., but there is no evidence that he lived there.

Forsyth, January 19th. 1850

Dear Son & Daughter Lokey,

I write you once more from the earthly house of this Tabernacle, which is not yet disolved though it has been pretty severely shaken - About the 6th. of December last commenced a tumor on the left side of my head which turned out to be a severe Carbuncle, it became very painful and continued so that I could take no rest day or night for three or four weeks and is not well yet but I am attending to business - My wife too has had a hard time nursing me, but thank God her health has been sustained and we are getting on the best we can.

Religion is as cold here I may say as ice, the Methodist Chiefly both Clergy and laity have quit religious duties and runaway with Free Masonry. Some of the Baptist, among them is the Pastoral supply of the Forsyth Church and newcomer (a preacher who has taken a female school here) by the name of Thomas. I fear such have the form of Godliness but by their acts deny its power. I feel like famishing if I stay in this church but as sheep of Christ are to go in and out and find pasture, finding none in, I shall seek for it out and shall find where ever I meet Jesus be it in his word which is my stay or in the closet where the Father sees in secret and rewards openly. There are the streames of my present consolation and sometimes but rarely I find a humble follower of Christ to take council with me here is the joy that the world and formal profession are destitute of, while they look down with contempt upon such humble pilgrims as ignorant, superstitious and opinionated fools.

I pray God for the purification of his church and I long to see her come forth in all her loviness and simplicity stripped of the false glory imposed on her by the slight of men.

I greatly desire to see you both but the distance is such and the emcumbrances upon you make it almost presumption to request you to come and as to my coming to see you it is out of the question without unforseen providential opening should occur - yet we may correspond by letter and thereby be constantly advised of each others welfare - write soon & often, it is not long you will have it to do. Affectiontely, Your Father, J. Anthony.

Dr. Thomas B. W. (or M.) Anthony is thought to have been the oldest child of James Anthony, Jr. and Elizabeth C. Blakey. Dr. Thomas may have studied medicine under his uncle, Dr. Milton Anthony. Dr. Thomas lived and practiced medicine in Garland, Butler Co., Ala. During the Civil War he is said to have stayed at home to care for the women, children and slaves. He is said to have had vertigo and fell from his horse dead in the road. His narriage to Sarah R. Wright, Oct. 23, 1834, is recorded in Talbot Co., Ga. Thomas B. M. Anthony, Talbot Co., drew in land lottery, 1832. Children:

Samuel Thompson Anthony, b. Jan. 7, 1851, Garland, Ala. d. Dec. 21, 1921, son of Dr. Thomas B. W. Anthony and Sarah R. Wright, md. Viola Marian Newson. Most of the children were born at Priscella, near Grapeland, Texas. He owned and operated a general mercantile store in Grapeland for 37 years. Mrs. Lynch said that coffins came without linings in those days and among many things she did at the store was to line the coffins. Mrs. Lynch said her mother's people came to Texas by boat up the river. The boat went aground and added to the hardship of pigneer life.

Samuel Anthony corresponded with Susan B. Anthony and they came to the conclusion that they were kin. Samuel received a formal announcement of Susan B.'s death. Samuel Anthony opened his home to the needy of his family, even the children of his cousin, The Bunyard children. Children:

HENRY TATE ANTHONY

Henry Tate Anthony, one of the older children of James Anthony, Jr., and Elizabeth C. Blakey, was born July 19, 1810 in Ga., died Sept. 23, 1877. Cherokee Co., Ala., md. Dec. 23, 1834, Talbot Co., Ga., Martha Anderson, b. July 17, 1818, Ga., died July 4, 1885. Their only child died in infancy. They adopted a daughter named Mary Lowe. Both Henry Tate Anthony, his wife, and adopted daughter and her husband are buried together in Shady Grove Cemetery, near Leesburg, Ala., across the river from Wood's Bend in Pollard's Bend. On his tombstone are these words, "I have fought a good fight, I have finished my course, I have kept the faith." Henry and Martha settled in Wood's Bend in Chreckee Co. 1835. The Indians were still there. Henry is said to have built a pole pen around a hollow tree as his first home. She helped him clear land in the day and he helped her spin and weave at night. The census of 1850 lists his property at \$1,300. and William Anthony, 19 yrs. of age, living with him. William is believed to have been his half brother. His brother, Robert M. Anthony, moved there just before 1850

census. "Uncle Henry' was the favorite relative of Robert's children. Henry Tate's nephew, Mark, told the following slave stories:

After the Emancipation Proclamation, a faithful old slave of Uncle Henry was told that he was free and could go any place he wanted to go. He replied that he had a good place and was going to stay there. He remained with his master the rest of his days and was given a Christian burial. This old slave was known to be faithful and peaceful by the neighbors. However night riders of the K.K.K. stopped at his house and asked for water. One of the riders drank several pails of water and continued to ask for more, pouring the water in a bag concealed on his person.

1832 Land Lottery, Cherokee, Henry T. Anthony, of Talbot Co., drew. His letters revealed his personality and Christian faith. He gave such good advice. No wonder they became keepsakes. To his teen-age nephew he wrote:

Oct. 11th 1872

Mr. R. H. Anthony

I received your friendly letter a few days ago and was much pleased to learn that you were engaged in such profitable business not for the wages alone but for the hope that you would persevere until you become master of the trade to perfection. The carpenters trade will be in constant demand in all times and all seasons for it is a thing that cannot be done without.

But there was another subject in your letter which I was pleased to see in which you seem to have taken an interest. You spoke of meetings which were carried on in that section of the country. This privilege all do not enjoy, you should esteem it very highly and make the best of such opportunities. But take not many opinions on matters of religion unless it is supported by the word of God. And as you have but a limited education you will employ all the time and means you have in trying to improve your education, seek every opportunity of trying to learn from those who are better informed than yourself, do not be too self opinionated but seek instruction at or from those whom you may have the oppertunity who are capable of instructing, and if there be any possible chance try to save a part of your wages to enable you to go to school, be determined on getting a better education. You will never have cause to regret it, but if you neglect it you will always as long as you live have cause to regret the lack of or want of it.

I have just written to John show him this and you read what I have written him. Please receive this as a token of my love and believe me to be your affectionate uncle until death, farewell.
